It is important that you spend at least 8 hours per week in these activities in order to fully realize the benefits of using the system.

Day 1: The Big Picture


1. Logging In

Once you have downloaded Mar-Kov Lite and created your account, it is time to log in.

Click the Mar-Kov Lite icon in your desktop



The system will load and prompt you for your username and password. Enter your credentials as follows:

Review Implementation Process

Implementing a new inventory management system can be simplified by following the outlined process. We highly recommend a single super user to learn and practice each module first, and then train the rest of the team for each module. This is important in order to create a concrete structure as well as for a designated individual obtain a big picture perspective on implementation.

We have gathered from our experience that the super user should follow the steps outlined below <u>for each module independently.</u> This is the best way to manage and introduce the change in a structured and manageable pace:

- 1) The super user learns of the functionalities of the module.
- 2) They practice it in the software.
- 3) Necessary data is entered to perform the functions
- 4) Training the end user with regards to each functionality
- 5) Going live with the module.

Going Live means that every real-life process is reflected in Mar-Kov Lite, for that module. For example: Going Live with the manufacturing module means that all the real-life manufacturing processes are performed on Mar-Kov Lite.



Days 2-7: Setup

1. Creating Items

The first step is to ensure that you have Items set up. This allows you to reference an item used in Mar-Kov Lite. For more information about Items and how to create them, please see: How to create Items

2. Creating Customers and Suppliers
